## CIRCUIT COURT NOTES

#### James A. Bonifant, Administrative Judge

### CRIMINAL PLEA AGREEMENTS

Even if a plea agreement is reached, attorneys are expected to continue to prepare for trial until the plea is accepted by the Court. Filing a plea memo is not a reason to stop preparing for trial. Witnesses should not be released until the plea is accepted by the Court. Stating a plea was not accepted at the last minute is not justification for postponement.

#### RESPONDING TO THE COURTS REQUEST FOR CASE STATUS

Due to the Court's backlog, it is imperative for the court to obtain an accurate assessment of the status of your case prior to trial. Surprisingly, emails from chambers or court staff have gone unanswered. Please respond as soon as possible to any emails received.

You will receive an email from Family Division Services (mccfamilycasestatus@mdcourtsgov) or the Civil/Criminal Case Managers (Nicole Pulliam — nicole.pulliam@mdcourts.gov or Annalese Bell — annalese.bell@mdcourts.gov) approximately three weeks prior to your scheduled trial. Thereafter, you may receive emails from the chambers of the assigned judge. You must

respond to these emails to advise as to the posture of your case and provide the information requested.

#### **INTERPRETER REQUEST**

The need for Court interpreters is on the rise. This includes the Court's staff interpreters and contract interpreters. Attorneys must notify the Court when they know an interpreter is needed. It is equally important that attorneys notify the Court when there is no longer a need for an interpreter.

If an interpreter is needed for a scheduled Court hearing and/or trial, please complete and submit a Request-for-Interpreter form (CC-DC-041) as soon as possible. Requests for interpreters should be submitted to the Court no less than thirty (30) days before the proceeding for which the interpreter is needed. The sooner the Court is aware that an interpreter is needed, the Court will be in a better position to accommodate the request and avoid a possible postponement.

Additionally, notify the Court at once when you learn an interpreter is no longer needed. Staff interpreters are often needed for more than one hearing occurring at the same time. The Court needs to avoid the expense of contract interpreters who are compensated when they report whether they are needed, or not.

Interpreters provide a valuable and needed service to the

Court. Their work is demanding and too often overlooked by those who rely upon their assistance. Please keep the Court informed of the need for an interpreter and when they are no longer needed. More importantly, take a moment and thank the interpreters for their help when you get a chance.

When trial time is underestimated it results in the need to set further hearings or additional trial days and it disrupts the already double and triple booked trial calendars. Your cooperation is appreciated.

#### ARRIVAL TIMES – CRIMINAL PRE-TRIAL AND 4-215/ SCHEDULING HEARINGS

A reminder to the Criminal Bar the importance of arriving on time to the Thursday and Friday Criminal Pre-Trial and 4-215/Scheduling Hearings. There is a lot of time and effort put into coordinating transportation and/or virtual appearances of Defendants' being held at the jail. To avoid delay and keep the docket running smoothly, please be on time.

the docket. Please file them in MDEC by 3:00 p.m. on Tuesdays. In addition, for those **last-minute dismissals**, we are asking attorneys to arrive in court at 8:30 a.m. and let the clerk know that a case is a dismissal; we will remove the case and it will not be called on the record. Hopefully this process will decrease the size of the docket. This is the same procedure that we used prior to Covid.

Please familiarize yourself with the recent case from the Supreme Cort of Maryland: Westminster Management, LLC, et al v. Tenae Smith et al. The Court addresses rent pursuant to Real Property 8-401.

Please remember the procedures for recalling arrest warrants. Attorneys who file motions to recall arrest warrants must have the consent of the State's Attorney's office for recall. In addition, the attorney must agree to accept service. Once the court signs the order and the summons is issued, the attorney must pick up the summons within two weeks of it being issued otherwise an arrest warrant will reissue.

When filing motions to continue in civil cases, please put available dates for trial in your motions. Preferably these will be dates you have cleared with opposing counsel so that cases can be resolved as soon as possible. Any motion that does not include possible trial dates will be denied. All motions to continue should be filed as soon as counsel becomes aware of a conflict.

There are many requests for remote hearings that either do not have a reason or do not fall into the Judiciary guidelines for a remote hearing. Each one of these motions is decided on a case-by-case basis. Any information that you think the court should consider should be in the motions. A reminder that all court filings must be done through MDEC and all motions must include an order.

I also invite anyone to review the District Court Admin-

istrative Regulations. They can be found on the Maryland Courts website at www.mdcourts.gov/sites/default/files/import/district/selfhelp/admin\_regulations.pdf.

Every month, there is a District Court Bench Bar Committee meeting via Zoom, and all are welcome to attend. It is the best way to get updates from the judges and clerk's office and ask those questions you have been waiting to ask.

#### **Seeking Current Court Rules?**



Our collection has three copies of the Rules in print, updated semiannually. These maroon books are located with our Michie's Anno-

tated Code of Maryland sets. Use Rules indexes to browse areas of law and relevant federal court rules. We also offer Maryland Advance Court Rules Service pamphlets alongside our Rules volumes. These include Rules updates and a discussion of related case law. If you are interested in learning more about the Rule-making process, consider attending the Standing Committee on Rules of Practice and Procedure meetings. Details for these meetings are on the Judiciary website at: mdcourts.gov/rules. A guide to past meetings can be found at: mdcourts.gov/rules/rulesnews.

## Correcting Mistakes and the Maryland Attorneys' Rules of Professional Conduct

Everyone makes mistakes. However, it is extremely important for attorneys to carefully evaluate all actions to discover whether a mistake has occurred and, if a mistake has been made, attorneys must act promptly and directly to attempt to correct the mistake as best as possible. Importantly, pursuant to Maryland Attorneys' Rule of Professional Conduct ("MARPC") 19-301.4/1.4 (Communication), since the attorney is also required to keep the client reasonably informed about the status of the matter, the attorney cannot 'bury' his or her head in the sand when a mistake is made during the course of representation and the attorney needs to explain the effect of the mistake "to the extent reasonably necessary to permit the client to make informed decisions regarding the representation." MARPC 19-301.4/1.4 (a)(2) and (b).

In Attorney Grievance Comm'n of Md. v. Woolery, Misc. Docket AG No. 15, September Term 2016, an attorney was reprimanded for making the mistake of selling an estate's expensive tractor (valued at \$10,000) for \$500 while having been appointed the personal representative of an estate. While the Court acknowledged that the actions taken by the attorney in selling the tractor for far less than its value was indeed a mistake, the Court stressed two instances where the attorney violated MARPC 19-301.1, 19-301.3, 19-308.4(a) & (d) and was reprimanded for his actions. Id.

The Woolery Court stated that a reprimand was appropriate

not merely because a mistake was made by the attorney (the attorney failed to ascertain the ownership or approximate value of the tractor prior to selling it), but because when "promptly informed of the tractor's ownership and value," the attorney failed to attempt to "rectify his error." Id. Thus, it is likely that if the attorney in question had merely acted to rectify the mistake immediately upon being informed of the problem, then the attorney might have avoided a professional conduct violation. As noted by the Court, "A mistake in the practice of law is not necessarily professional misconduct. However, once aware of a mistake that harms another and given the opportunity to mitigate it, a lawyer who decides to do nothing may be

**guilty of misconduct."** *Id.* (emphasis added)

In another case, Attorney Grievance Comm'n of Md. v. Walker-Turner, 428 Md. 214, 51 A.3d 553 (2012), an attorney was reprimanded for making the mistake of not appearing for a trial while being outside the courtroom on the phone with his client. In this case, the Court similarly acknowledged that mistakes – such as being in the wrong area of the courthouse – happen. However, the Court believed that the attorney "incompetence" at issue stemmed from that the fact that nothing was done by the attorney after learning that his case had been called, that he had failed to appear, and that a default judgment had been entered against his client. The Court stated, in

(Continued from preceding page) part, that sanctions were appropriate because, "[h]ad [the attorney] acted earlier to confirm what happened in the courtroom when the case was called and he was not present on 26 January 2007, he and his clients would have been spared the consequences that followed." Rather, upon realizing his mistake, instead of acting to rectify the mistake with the Court, the attorney assumed the problem would merely resolve itself, since he believed that had "settled" the case the day before trial. Despite attempts to eventually rectify the default judgment against the client, the judgment appeared on the client's credit report. The Court expressed that "These actions show a lack of diligence in his representation of his clients and, thus, violate [MARPC] 1.3." Id. at 228.

Additionally, the Walker–Turner Court also found misconduct because the attorney failed to timely inform his clients of his mistake. As noted by the Court, "An attorney is required to keep his/her client informed reasonably as to the status of a matter undertaken by the attorney. [MARPC] 1.4(a)(2). The attorney must explain the matter to the extent reasonably necessary

to allow the client to make informed decisions about the course of the representation. [MARPC] 1.4(b). [The attorney] did not inform timely [the client] that a judgment was entered against him ... because of his failure to appear at the trial or ascertain the actual disposition of the case. Because of the failed communication, [the client] was not able to make informed decisions as to the best course to correct [the attorney's] earlier failures. [The attorney's] self-inflicted period of oblivion as to the existence of the judgment is the reason for his failure to communicate properly with his clients." Id. at 231 (emphasis added). If the attorney had acted to correct his mistake, and had timely informed his client of his mistake, the attorney may have been spared a professional conduct violation finding.

In another case, Attorney Grievance Comm'n of Md. v. Slate, 457 Md. 610, 180 A.3d 134 (2018), an attorney was sanctioned for failing to disclose during the bar application process certain information related to a past civil litigation action where he was a party. In this case, the attorney maintained that he made a mistake by omitting information in his bar applica-

tion about that action. However, when the attorney was provided with multiple opportunities to rectify the "mistake," the attorney failed to do so. In fact, when confronted with the existence of the missing information, the Court noted that the attorney compounded the problem by "falsely affirm[ing] under oath that all of the facts in his bar application remained correct," "not supplement[ing] his bar application with the trial court's opinions or the findings therein," not "disclos[ing] the trial court's opinions or the findings therein during the character interview, and not "disclos[ing] the information during a meeting with the cochairs of the Character Committee for the Fourth Appellate Judicial Circuit ('the Character Committee')." Id. Succinctly, the attorney failed to correct what the attorney claimed to be a bar application "mistake." The Court concluded that the violation finding was not "because he merely made a 'mistake," but rather because of the attorney's continued "concealment" of the information that was left out of the attorney's application. Id.

Timely actions to correct a professional responsibility mistake are important. Not

only could such immediate corrective actions eliminate a MARPC violation in its entirety; but such actions are also mitigation factors in determining sanctions for a MARPC violation. See Attorney Grievance Comm'n of Md. v. Reno, 440 Md. 414, 103 A.3d 565 (2014) ("Mitigating factors include . . . timely good faith efforts to make restitution or to rectify consequences of the misconduct."). Ultimately, in legal practice, as in any profession, mistakes happen. However, prompt and direct action to attempt to correct such mistakes are important to not only avoiding a determination of a professional conduct violation but also as to any determination as to the severity of the sanctions if a violation is found.

A warning given by former President Barak Obama to those not wishing to engage on the issue of climate change is appropriate here: Sticking your head in the sand is not going to protect you from the coming storm.



# WHICH BOX DO YOU PICK?



"If I am a Mongolian, then so was Jesus, because we came from the same land" declared George Shishim, originally born in Lebanon. As stated in my February article, "... the [United States] Census Bureau excludes countries in two geographical areas in Asia - Central Asia and West Asia/'Middle East' and places them under the race category of White." Many groups have in fact unsuccessfully lobbied for a Middle East and North Africa" (MENA) category in the U.S. Census for the past 30 years. Countries in West Asia/ Middle East include Afghanistan, Armenia, Azerbaijan, Bahrain, Cyprus, Georgia, Iran, Israel, Jordan, Kuwait, Lebanon,Oman, Palestine, Qatar, Saudi Arabia, Syria, Turkey, United Arab Emirates, and Yemen. Countries in Central Asia include Kazakstan, Kyrgyzstan, Tajikistan, Turkmenistan, and Uzbekistan. This fact brings up several questions: 1) How did this race classification happen? 2) Why does it matter? 3) What is the current impact on this race classification?

In answer to the first question, it is important to look back at the historical context of the United States. As explained more thoroughly in the February article, in the early 1900s to 1920s, all Asian immigrants were denied U.S. citizenship and naturalization, prevented from marrying Caucasians, and prevented from owning land. This was the backdrop of the 1909 landmark Californian court case, United States v. George Shishim, where as a Lebanese immigrant, Shishim refused to be categorized "Chinese/Mongolian" and claimed to be white. Simultaneously, the Arab immigrant community raised money and fought in courtrooms and through newspapers to prove their "whiteness." As a result, U.S. citizenship was expanded to allow for Lebanese, Syrians, and all Arabs, distancing them from the discriminatory practices that would remain against Asians in the United States until 1952.

The lack of separate racial classification by the U.S. Census Bureau matters because diversity and inclusion is most effective, not when color blind or muddled into one color, but when the dynamic palette of colors is recognized and respected.

The U.S. Census Bureau estimates there are around 1.8 million Arab Americans in the United States, whereas the Arab American Institute (AAI) puts that figure closer to 3.7 million. As the AAI explains, the undercounting of Arab Americans "has served as a barrier to representation, education, health, and employment for the community" in numerous ways. Writer Arwa Mahdawi points out that it affects "the availability of foreign language ballots at polling places; research grants for ethnic-specific diseases; and protection against discrimination." When the catastrophic terror event from September 11, 2001 occurred, the race classification mattered even more considering that many under the MENA category went through considerable persecution and racial profiling, but the data was unclear because there was no separate race classification to gather data and statistics.

The lack of a separate racial category matters even today in topics like affirmative action through the recent Supreme Court decisions in *Students for Fair Admissions v. Harvard*, 600 U.S. 181 (2023).

Until the MENA race category is separately established and/or a separate specialty bar association is created in Maryland, the Asian Pacific American Bar Association of Maryland (APABA-MD) has the perspective that the term "Asian Pacific" encompasses a broader and more inclusive definition of all of Asia (including East Asians, South Asians, Central Asians, West Asians/ the Middle East) and Pacific Islanders. So, as a celebration of our diversity, it is important to note this year's past celebrations: Happy Nowruz (Persian New Year) on March 19 & Happy Holi (Festival of Colors) on March 25, and Eid Al-Fitar (the end of Ramadan) on April 10. We also invite everyone to celebrate at the Asian Pacific American Bar Association of Maryland gala on May 8, 2024 from 6pm-9pm at VisArts as we honor Asian Trailblazers in the Judiciary in Maryland!

On April 11, 2024, the IRS published its 2024 Dirty Dozen campaign initiatives in IR-2024-105. The purpose again was to alert taxpayers as to risk of losing money, personal information, data, plus. This year's list consisted of the following categories:

- (1) Syndicated conservation easements
- (2) Micro-captive insurance arrangements
- (3) Schemes to park money offshore with false promises of not having to report to the US.
- (4) Maltese retirement arrangements through the tax treaty with Malta
- (5) Digital assets including convertible virtual currency and cryptocurrency, stablecoins and non-fungible tokens (NFTs). Promoters will again say these assets are untraceable and undiscoverable by the IRS which is not true.
- (6) Reporting digital asset income: gain & sale even when paid as compensation.
- (7) Eye on compliance

To report an abusive tax scheme or a tax return prepar-

er, people should use the online Form 14242 – Report Suspected Abusive Tax Promotions or Preparers, or mail or fax a completed Form 14242 and any supporting material to the IRS Lead Development Center in the Office of Promoter Investigations.

#### WORKERS COMPENSATION LAW SECTION

The Hon. Maureen Quinn, Chair of the Maryland Workers' Compensation Commission, will be attending to discuss CompHub, Commission updates, and hot tips for practitioners. We will also hold a roundtable discussion of current cases.

#### Recent reported cases:

In the Matter of Zukowski, 260 Md.App. 220 (2024), the Appellate Court held that when an offset against benefits applies, the attorney fees are calculated from the actual amount due after taking into account the statutory offset, not from the Commission's award.

In Ledford v. Jenway Contracting, Inc., 259 Md.App. 534 (2023), the Appellate Court held that in the case of a work-related death, a non-dependent daughter was still precluded by the

exclusive remedy rule from bringing a wrongful death claim.

In the legislature:

Several bills this past session have made it to the Governor's desk. HB584/SB476, "Caring for Public Employees in the Safety Professions - CAPES Act", was passed by both houses. This would add thyroid, ovarian, and colon cancer to the list of presumption cancers in Md. Code, Lab. & Empl. §9-503. Also to the Governor is HB669/SB843, amends §§9-505 and 9-650 to include for consideration the higher-frequency 4,000 hertz when calculating hearing loss, and removes the requirement that tinnitus be considered to be a part of a compensable hearing loss.

The following did not make it past committee: HB190/SB1069, which proposed a PTSD presumption for first responders; HB915/SB789, which would have required the Uninsured Employer's Fund to adhere to payment deadlines; HB1285/ SB931, which would have authorized certain licensed social workers to register as rehabilitation practitioners and to provide evaluation services for workers' compensation claims related to permanent impairments involving a behavioral or mental disorder, HB1050/SB919, which would have extended the period of reopening of claims by 60 days; and HB1145/SB844, which would have altered the requirements for a finding of presumption hypertension in certain first responders, including pre-employment exams and prescription of medication for the hypertension.

## **Family Ties and Trade Secrets**

Family businesses are often fraught with internecine power struggles, and the squabbles among potential successors can destroy the business. The show <u>Succession</u> amply demonstrates this.

In a recent Appellate Court for Maryland case, Timothy Ingram, et al. v. Cantwell-Cleary Co., Inc. (Md. App. Dec. 22, 2023), after a family feud in the Century-old company, a disgruntled son schemed to take the business away from his mother and siblings. Key employees removed trade secrets and confidential business information and joined the son in a competing company (collectively "Defendants"). The new company, Cleary Packaging, Inc., with customer lists, pricing information, vendor pricing, profit margins and other trade secrets taken, immediately competed in various packaging supplies sectors. Plaintiff Cantwell-Cleary sued the parties on various grounds, including breach of contract, civil conspiracy and misappropriation of trade secrets.

The lengthy case hinged on several issues, including what constituted a "misappropriation" of a trade secret under the Marvland Uniform Trade Secrets Act (MUTSA). Defendants' argument that customer lists and pricing information cannot constitute a trade secret was readily dismissed. Indeed, most trade secret litigation involves such confidential and valuable information having economic value, e.g., for car dealerships the very confidential client list is critical. Even information memorized by the Defendants can be considered trade secrets if confidential.

The further argument that Plaintiff did not take "reasonable efforts' to maintain the secrecy of the trade secrets were belied by numerous documents signed by the Defendants and

company policies contrary. Indeed, many of the protective measures were breached by the Defendants in obtaining the company confidences and trade secrets in the days leading up to the departure of Defendants from Plaintiff's company. Misappropriation was amply established under these circumstances.

Another issue before the Court was the damages determination at trial. Here, the Court chided the trial court's adoption of Plaintiff's damages expert, particularly finding that the expert did not properly demonstrate that the damages were caused by the misappropriation. For example, the expert's analysis included damages computed from past gross sales, lost sales to customers who did NOT follow Defendants to the new competing company, and other factors. As such, since the claimed loss was not demonstrably "attributable to the appropriation of the trade secret," this predicate was not made, and the case was remanded for a proper computation of the damages.

On remand, the Appellate Court noted that the trial court's damages determination should instead be based on the Defendant's gross sales received from diverted customers due to the trade secret misappropriation, and the application of Plaintiff's profit margin to the diverted sales.

Also, the trial court expert established a three-year period of damages, which the Court questioned since it was possible that the Defendants could perhaps discover the confidential information on their own over a shorter period of time. In other words, the requisite durational period for damages under MUTSA is limited to "the period of time that the information would have remained unavailable to the defendant in the absence of appropriation." Despite rather flagrant theft, the doctrine of trade secret law does condone independent discovery (absent fraud). Plaintiff thus must show a sufficient causal relationship, over a particular period of time after the misappropriation (to be determined), regarding the losses incurred due to the misappropriation. In other words, your expert cannot generally allege damages.

The issue of misappropriation, however, is not in question. Plaintiff did a good job of protecting their trade secrets and confidences: Non-Compete Agreements, employee handbooks and other materials

were sufficiently binding on the Defendants. Computer security is good to a point. Here, documents were deleted and information easily copied by those Defendants, who possessed the authority to act for Plaintiff, on the days leading up to their departure. Tiered computer security permissions to restrict access would help, and could be modified pursuant to the circumstances.

Just as with the Roy family in *Succession*, the parties here were plagued by intrigue. The Defendant son's antagonism toward his mother is the stuff of Aeschylus and other Greek tragedians, and the death of the patriarch drove the personalities.

For family businesses or any business that has confidential and valuable information or data critical to the company, whether a customer list or a chemical formula, take measures to protect that secret or it will be lost. The Appellate Court has affirmed that the scope of trade secret protection is broad in Maryland. To the extent a valuable resource can be patented, that option is also available. Consult an intellectual property attorney if you have any questions on these subtle issues.

## **Notice for Summary Ejectment Suits in Maryland**

This article explains the current law regarding written notice that a landlord must provide to tenant before filing a complaint for summary ejectment in failure to pay rent case. This article explains the law governing residential properties only.

There are two types of residential properties in Maryland, viz covered properties and other properties. If the tenant lives in a covered property, then the landlord must comply with federal law before filing a suit for summary ejectment, else the landlord is required to comply with the state law. The court may dismiss the landlord's

complaint, if proper notice, as required by federal or state law, is not provided to the tenant.

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law No. 116-136, §4024 defines Covered Property. The section 8 housing vouchers, federally subsidized housing, public housing, etc. are included in the definition of covered properties. If the tenant is living in a covered property, then the landlord is required to give a thirty-day notice prior to filing a complaint for summary ejectment in failure to pay rent case.

The landlord must check whether the property is a cov-

ered property prior to giving notice to tenant. If the property is not a covered property, then state law applies, and the landlord is required to give a tenday notice to the tenant instead of a thirty-day notice. There is no form for a thirty-day notice. However, for a ten-day notice the state law requires the landlord to provide the notice only on the form created by the Maryland Judiciary. If the tenday notice is not provided on the Maryland Judiciary form, then the court may dismiss the landlord's complaint.

The landlord may serve the tenday notice by first-class mail; or by affixing it to the door of the leased premises; or by email, text message, or through an electronic tenant portal — only if the tenant has elected to receive notices by electronic delivery. In the complaint, the landlord must state when and how the ten-day notice was provided to the tenant. The court may dismiss the complaint if the landlord does not properly serve the notice on the tenant.

To conclude, if a tenant lives in a covered property, then the landlord must give a thirty-day notice, else the landlord must give a ten-day notice prior to filing a complaint for summary ejectment in failure to pay rent cases.


