IN THE PURSUIT OF JUSTICE

Maryland Legal Aid (MLA) is a statewide private, nonprofit law firm that provides free, civil legal services to low-income and vulnerable people to address their most fundamental legal problems. From its 12 offices around the state and through its many community-based clinics, we help our clients preserve and access safe and affordable housing, maintain custody of their children, and be safe from domestic violence. MLA increases our clients' economic security by defending against consumer debt, including foreclosures and tax sales, removing barriers to employment, and accessing critical income supports such as unemployment, food stamps and other vital public benefits. Through special projects, we represent seniors, nursing home residents, children in alleged abuse and neglect cases, migrant farmworkers, and those in mental health institutions. In its advocacy, MLA seeks systemic change through impact litigation, policy advocacy and by telling our clients' compelling stories.

We continued to show up every day to address our clients' most critical needs in fundamental areas such as housing, consumer protection, family law and domestic violence, economic empowerment and income support. These efforts were crucial in a year marked by persistent challenges, including the ongoing effects and loss of pandemic-related support for vulnerable people in our state.

Our achievements this year on behalf of those we represent were made possible through the collective efforts of our staff, volunteers, partners, and, importantly, our funders and donors. Your belief in our mission has been instrumental in our ability to respond swiftly and effectively to the evolving needs of our fellow Marylanders. As we look toward the future, your continued support is vital in ensuring that Maryland Legal Aid can sustain and expand its essential services.

Thank you for standing with us in 2023. We look forward to our continued partnership and the strides we will make together in the coming years to ensure a more equitable, inclusive and just society for us all.

WHAT'S NEW MLA'S VISION AND NEW STRATEGIC PLAN

Maryland Legal Aid launched its strategic planning process in 2023 and made significant progress toward crafting a new strategic vision for the future. We engaged a consultant to help design an inclusive process that involved all our staff and board through an organizational assessment, focus groups, and surveys. Importantly, the process involved more than a hundred staff in twelve staff-led workgroups, six of which were focused on our legal substantive work and six focused on our organization. The workgroups examined our current practices, spoke with key stakeholders, researched best practices, and developed recommendations for our future direction.

In October, all our staff and board came together in Ocean City, thanks to the support of an MLSC one-time grant. At the retreat, the workgroups presented their recommendations and gave feedback about our new mission, vision, and core values. We also enjoyed a chance to be together, celebrate staff milestones and successes and have some fun.

Armed with invaluable input and feedback from staff and other key stakeholders, a strategic planning committee consisting of staff and board members crafted a draft plan. The strategic plan, that will lay out MLA's strategic direction for the next five years is scheduled for board approval in spring 2024.

CHANGES TO EXPUNGEMENT LAW WITH LEGALIZATION OF CANNABIS: New Opportunities for Relief

On July 1, 2023, Maryland legalized cannabis for adults 21 and older. In October, the law regarding expungement changed decreasing the time for expungement relief for certain offenses. Maryland Legal Aid joined forces with other legal services partners to help educate people about the changes in the law and to support statewide expungement efforts.

Maryland Legal Aid, with its legal services partners, mounted an extensive outreach and education campaign about the relief available under Maryland's new laws. We also began a robust series of collaborative community clinics involving staff and volunteers who advised people about their rights and assisted in preparing expungement petitions. Our lawyers filed those petitions in court to ensure that people received the critical, life-changing relief the new laws provide.

Maryland Legal Aid also conducted training sessions with community partners. The first one was aimed at practicing attorneys and held at the Judicial College of Maryland in partnership with Maryland Volunteer Lawyers Service. The second training was focused on case managers and social workers at the Maryland Department of Human Services who are part of the Emerging Adult Workgroup at DHS that assists young adults transitioning out of the foster care system with employment, housing, and other resources.

TENANT RIGHT TO COUNSEL PROJECT EXPANDS TENANTS' RIGHTS BY PROVIDING LEGAL REPRESENTATION FOR MARYLANDERS FACING EVICTION

In 2023, Maryland Legal Aid launched the Tenant Right to Counsel Project (TRCP) as part of the statewide implementation of the Maryland Access to Counsel in Evictions ("ACE") Program. Only one of three states to provide a right to counsel for low-income Marylanders facing eviction, the program has tremendous potential to make a real difference for tenants and, in this early phase of implementation, it already has. We have expanded our capacity, resulting in more than 50 paralegals and attorneys spending 22,700 hours to provide vital legal representation to Maryland tenants under threat of eviction.

To reach Marylanders who qualify for representation but may not know that they have a right to counsel, the ACE program includes "same-day representation" in rent court. Maryland Legal Aid, as the only statewide provider, is part of these efforts in every jurisdiction. We provide day-of-court assistance to tenants, including in Baltimore City, Washington County, Carroll County, Charles County, Montgomery County and Frederick County. Maryland Legal Aid's staff and its Equal



Justice Works Housing Justice Fellows have been engaged in community-based outreach efforts as well to inform tenants about their rights and the legal representation available by law.

In this early stage of the program, the Tenant Right to Counsel Project has made a meaningful difference. Our representation has prevented an eviction or subsidy termination in 39% of closed cases and delayed an eviction in 30% of cases, thereby helping clients avoid sudden displacement. In many other cases, clients were able to have critical repairs done, avoided unfair charges, or obtained other benefits such as reasonable accommodations.

Maryland's right to counsel law ensures that income-eligible renters shall have access to free legal representation when faced with eviction. MLA is pleased to play a part in our state's transformational effort to prevent eviction, ensure safe housing and promote greater housing stability.

MARYLAND LEGAL AID BOARD LEADERSHIP TRANSITIONS

Warren Oliveri, who served on Maryland Legal Aid's board of directors for 37 years and as president of the board for most of that time, stepped down from the board last June. The board elected fellow board member, Brian Hochheimer, to serve as the next board president.

Warren's leadership and commitment to Maryland Legal Aid was extraordinary. During his many years on the board, Warren played an instrumental role in the growth and development of the organization, elevating its profile and extending its reach to be able to serve clients from multiple offices throughout our state.

"We are grateful to Warren for his steadfast dedication to the mission of Maryland Legal Aid and his unwavering support," said MLA executive director Vicki Schultz. "Though he is no longer on the board, we know that Warren will always remain a true friend to Maryland Legal Aid." Schultz added, "We appreciate Brian's willingness to assume leadership of the board and look forward to his fresh perspective and innovative ideas as he leads MLA through this important and impactful transition."

REPORT

MR. K.'S PATH TOWARDS STABILITY AND WELLNESS

Mr. K. worked as a behavioral health counselor for more than a decade, helping individuals struggling with mental health and substance abuse issues. Last July, his life took a devastating turn when he suffered a massive heart attack. He could no longer work and was placed on the waiting list for a heart transplant.

Without any income, Mr. K. was unable to pay rent and buy food. He often had to ration his medications, forcing him to endure excruciating pain. Though he applied for disability income assistance, Mr. K. waited for nearly a year for a decision.

During that time, his landlord tried to evict him multiple times and refused to accept the rental assistance for which Mr. K. was eligible. Mr. K.'s life-saving heart medication required refrigeration, so the prospect of homelessness became a life-or-death situation for him.

Fortunately, through its Medical-Legal Partnership with Kaiser Permanente, Mr. K. was referred to Maryland Legal Aid. MLA Staff Attorney Cory Warren navigated multiple legal battles with Mr. K., including winning three separate failure-to-pay-rent cases over the course of the year.

Mr. Warren got the landlord to accept rental assistance payments for which Mr. K. was eligible. He also helped Mr. K. execute a power of attorney and an advanced directive to give him peace of mind.

When clients like Mr. K. face such high-stakes situations, they should not face it alone. Marylanders deserve the holistic representation and tenacious advocacy MLA provides its clients every single day. He went beyond what I expected, and if it were not for his efforts, I could have very well been trying to survive this past winter homeless. He shielded me from every effort to force an eviction and I truly believe he helped save me.

I would not have been able to fight this alone."

A LEGAL JOURNEY FOR A CHILD'S SAFETY

While at the Prince George's County Courthouse, Morgan McManus, a domestic violence and family law lawyer for Maryland Legal Aid, overheard a woman in distress discussing her order of protection. McManus asked the woman, Mary Jones,* "How can I help?"

Her children, Jones said, were being abused by their father, who also refused to address the mental health needs of one of the children. Jones said she had been battling with the father for nine months. Angered by her request for a protective order, the father responded by asking the court to change the agreement and let him have sole custody of one child. Jones said she felt harassed and exhausted by his attempts to retaliate, continuous disappearances and his lack of follow-through.

McManus immediately advised her to start the intake process with MLA. McManus promised to follow up with her the next day if she did.

Knowing that the custody modification requested by the father was not in either child's best interests, MLA agreed to represent Ms. Jones. McManus went into action and filed a countermotion to appoint a child privilege attorney, citing the father's abusive behavior.

After McManus joined the case, the father neither participated in the court proceedings nor cooperated with the privilege attorney. Seeing that, as well as the evidence of abuse, the judge gave Jones full custody of both children along with the discretion to determine if and when the children would have access to their father.

The father made a last-ditch effort before the order took effect to change custody and suspend his child support payments. However, the judge ruled in favor of McManus' motions to dismiss both possibilities, awarding Jones full custody of both children and restoring her peace of mind regarding her children's safety.

ENDURANCE AND JUSTICE

In February 2019, Fiona Johnson,* who has multiple sclerosis and is unable to work because of the degenerative disease, came to Maryland Legal Aid for help with her divorce.

She had been married for almost 20 years and had endured years of physical and verbal abuse from her husband. But when Johnson discovered her husband's infidelities, he told his wife to move out of the couple's home, which they owned jointly, to allow his girlfriend and her family to move in.

Johnson's only support was her monthly Social Security disability income of \$1,100. Yet, her husband forced her out without any more financial considerations. Johnson could afford only a single room for \$650 monthly in a small home where four people shared one bathroom.

Since she could no longer work, Johnson could not afford an attorney, but she wanted to live independently, so she turned to MLA and was helped by the persistence and tenacity of Chief Attorney Jeff Kaplan.

It was a long and drawn-out case, not only because of the COVID-19 pandemic but also because the husband refused to comply with the court decisions. Finally, after a yearlong delay, Johnson's husband was ordered to either pay Johnson \$50,000 for her share of the marital home or sell the house and give Johnson 85% of the proceeds.

When the deadline came, Johnson's husband refused to move and did not refinance the mortgage to pay the \$50,000, despite having the financial ability to do so.

Kaplan hired a realtor to sell the house, but the husband repeatedly stalled the process. Stubbornly, her ex-husband also abdicated all homeowner responsibilities, refusing to pay water bills, taxes and environmental violations. The house deteriorated, and a year later, Johnson received only \$30,000 when it was sold.

Kaplan and MLA's new staff attorney, Michael Braunstein, thought justice had not been served, so they reopened the case and argued that the ex-husband should be held responsible for his actions.

Finally, after three years, Johnson was recently awarded an additional judgment of \$28,000 against her ex-husband.

PRESERVING HOME AND HOPE: CATHERYN'S STORY

In the winter of 2023, Catheryn sought help from Maryland Legal Aid to save her home in Annapolis. As a disabled veteran who used a VA loan to buy her house, she fell behind on mortgage payments due to issues with Navy Federal Credit Union and ongoing health problems. Despite the looming threat of foreclosure, Catheryn approached MLA before the mediation deadline expired.

Supervising Attorney William "Bill" Steinwedel took swift action, guiding Catheryn through the Maryland Homeowners Assistance Fund (HAF) application process. With Steinwedel's help, Catheryn secured \$11,978.22 in HAF funds, enough to cover her mortgage arrears. With financial support and MLA's backing, Catheryn presented a compelling case to the court, leading to the dismissal of the foreclosure case and withdrawal of her mediation request.

The collaboration between Catheryn and Attorney Steinwedel not only saved her home but also brought hope and stability to her life.

Steinwedel's dedication recognized Catheryn's service as a disabled veteran, prioritizing her well-being. With foreclosure averted, Catheryn could focus on rebuilding her life, supported by MLA and the HAF funds, paving the way for a more secure future.

ADVOCATES IN ACTION: 2023 IMPACT CASES

Maryland Legal Aid attorneys have a long tradition of impact work, including in the Supreme Courts of Maryland and the United States. Impact cases are part of our broader advocacy efforts and are crucial to create fairer and more equitable policies and systems. These cases go beyond one individual client to affect a group of individuals, the legal system, or society.

WESTMINSTER MANAGEMENT, LLC, V. TENAE SMITH

In August 2023, MLA, with a coalition of nonprofit organizations across the state, filed an amicus brief in the Supreme Court of Maryland on behalf of vulnerable low-income tenants facing eviction. This case involved a legal dispute with Westminster Management's broad interpretation of the word "rent" in residential leases, claiming it encompassed other costs, such as eviction and other expenses. The coalition challenged this view, emphasizing the potential harm to vulnerable tenants, including homelessness and various hardships, if the Court were to adopt Westminster's broad definition of rent. The Supreme Court of Maryland recently ruled in favor of the tenant appellant concurring with the argument MLA made in its amicus brief.

UNITED STATES V. RAHIMI

In August 2023, MLA joined the Texas Advocacy Project and a coalition of dedicated nonprofit organizations across the nation in filing an amicus brief in US v. Rahimi. The brief was in support of ensuring the safety and protection of domestic violence survivors through appropriate firearm regulations. By joining forces to submit this critical amicus brief, Maryland Legal Aid aims to correct the misinterpretation of the law and advocate for the continued protection of domestic violence survivors.

MLA SEEKS TO PROTECT DISABLED SENIOR CITIZENS IN BALTIMORE FROM DANGEROUS AND ILLEGAL PRACTICES

In August 2023, Maryland Legal Aid filed a lawsuit in Baltimore City Circuit Court on behalf of senior citizens, including individuals with disabilities and a veteran, residing in unlicensed properties. The properties have numerous safety and housing code violations, including rodent infestation, water damage, mold, and fire hazards. As a result of the defendants' actions and failure to maintain their properties, the senior citizens living in these properties have experienced a range of health issues, both physical and mental, including depression, anxiety, and heightened stress. The lawsuit seeks to hold the landlords accountable for violating rental license laws and failing to provide safe and decent housing for the plaintiff.

THE RYAN WHITE PROJECT

Since 2012, the Ryan White Project has provided free legal services to Maryland residents who are HIV positive or who have AIDS. This service is available to all those who live in Baltimore City and Anne Arundel, Baltimore, Carroll, Harford, Howard, or Queen Anne's counties. This year, we assisted 71 Ryan White Clients with 95 legal matters.

This crucial assistance addresses the legal needs of people living with HIV/AIDS and enables them to focus on their primary concern — staying healthy. MLA is committed to this life-changing work and protecting people from discrimination. Legal services, in combination with medical care and case management assistance, are crucial to the well-being of people living with HIV/AIDS.

NEW LAWYER TRAINING

As the state's largest provider of free, direct legal services, we not only offer a comprehensive benefits package that's market-competitive we also work hard to keep our employees on a path to success through our training programs.

In 2023, MLA offered its extensive, hands-on New Lawyer Training program focused on developing and improving litigation skills. This year, we added a writing component to the training. Between seminars and practical exercises, the attorneys received invaluable feedback from seasoned lawyers at the Bon Secours Retreat and Conference Center in Marriottsville. The culminating event was a mock trial that enabled participants to engage in trial proceedings and receive valuable critiques from our guest judges.

COMMUNITY LAWYERING INITIATIVE

Maryland Legal Aid's Community Lawyering Initiative places highly skilled lawyers directly in under-served neighborhoods to provide free,

life-changing legal assistance. Through these communitybased clinics, we have grown our presence in the community. These clinics, staffed by MLA's attorneys and paralegals along with pro bono attorneys and law students, help people access legal assistance right in their own community.

Community advocacy is a strategic approach to influencing outcomes and driving change on behalf of the community. The Community Lawyering Initiative includes weekly and monthly expungement clinics coordinated and hosted with community organizations from around the State!

ALL STAFF & BOARD STRATEGIC PLANNING RETREAT

Kyle Coleman, a staff attorney in the Housing Consumer Unit from the Baltimore City Office, was given the Diane Kinslow Award, named for our CINA (Child in Need of Assistance) staff attorney. Coleman was recognized for demonstrating courage and compassion in his services to our clients.

MCLA UPDATE

The Court Help Centers are part of a project run with the support of the Maryland Judiciary by the Maryland Center for Legal Assistance (MCLA), a wholly-owned subsidiary of MLA. With a call center in Annapolis that serves the entire state, MCLA helps fill the justice gap by serving self-represented litigants and referring eligible people to MLA and other legal services programs. The Maryland District Court Help Center walk-in locations are in Baltimore City, Cambridge, Catonsville, Glen Burnie, Hagerstown, Rockville, Salisbury, and Upper Marlboro; and the Circuit Court Help Centers walk-in locations are in Frederick and La Plata.






