Establishing strong partnerships has been fundamental to the overall success of Maryland Legal Aid and the strengthening of our mission to ensure equal access to justice for all. In 2016, Maryland Legal Aid successfully executed new initiatives, expanded existing programs, and focused on establishing partnerships with community organizations and other entities whose missions aligned with ours, all while continuing to provide high-quality civil legal advocacy to clients statewide.

While Maryland Legal Aid provides a broad spectrum of high-quality services, these partnerships enable us to offer more in-depth and targeted assistance to address many inter-related issues that our clients face. The **power of partnerships** is an integral part of our daily work and long-term mission, and throughout this 2016 Annual Report, you will find examples of how strategic collaborations with a wide range of community partners have significantly improved outcomes for individuals and communities.

For example, Maryland Legal Aid's *Community Lawyering Initiative* is a cutting edge project that places highly-skilled attorneys directly in underserved neighborhoods to provide free, immediate, and life-changing legal assistance. Since the inception of the *Initiative*, Maryland Legal Aid has partnered with 50 community organizations and institutions to host and coordinate statewide legal clinics and events; these partners include bar associations, private law firms and in-house counsel, law enforcement, elected officials, and other local charities. The *Initiative* has enabled Maryland Legal Aid staff, pro bono attorneys, and law students to dramatically expand Maryland Legal Aid's reach beyond its 12 full-service offices to additional neighborhoods and locations. Maryland Legal Aid was also fortunate to bolster its partnership with Venable LLP through Venable's Loaned Associate Program. Through this program, Venable attorneys are embedded in the Housing and Consumer Unit of Maryland Legal Aid's Baltimore City office and work with staff and clients on a number of civil legal issues including bankruptcy, foreclosure and landlord-tenant issues.

Many of the other successful partnerships established and continued in 2016 are funded by foundation and government grants. *Project Household* was funded by a grant from the Leonard & Helen R. Stulman Charitable Foundation and enables Maryland Legal Aid and other legal services providers to work together to help seniors in Baltimore City preserve homeownership through direct legal representation and education. Through a three-year grant from the United States Department of Justice's Office on Violence Against Women (Legal Assistance for Victims Grant Program), Maryland Legal Aid continues to collaborate with TurnAround, Inc. to provide holistic civil legal representation for victims of sexual assault and domestic violence in Baltimore City and Baltimore County. Thanks to a generous grant from the Governor's Office of Crime Control and Prevention through the Victims of Crime Act, Maryland Legal Aid is able to expand services available to victims of sexual assault and domestic violence through TurnAround, Inc. and a new partner, CHANA. These are just a few of the new and ongoing partnerships that create second chances, viable options, and meaningful change for Maryland individuals and families, many of whom have been marginalized.

For the past 106 years, Maryland Legal Aid has provided critical legal services and assistance to Maryland's most vulnerable individuals and communities. We are extremely grateful for the stalwart and steady support and contributions of staff, Board, Equal Justice Council members, pro bono attorneys, volunteers, donors, foundations, governmental funders, most notably the Maryland Legal Services Corporation and the federal Legal Services Corporation, and all of our community partners, who make it possible for us to fulfill our mission and pursue our vision for a fairer and more just society for all.

MARYLAND LEGAL AID'S

Community Lawyering Initiative

In 2016, Maryland Legal Aid established the Community Lawyering Initiative, which brings free and critical legal resources directly to people in their communities. Maryland Legal Aid designated internal resources and staff to manage the Initiative—which includes hosting legal clinics around the state to assist clients with their criminal record expungements and civil legal issues. Since the start of the Initiative, Maryland Legal Aid has developed a number of integral relationships with community partners that have enabled the Initiative to grow and flourish as a successful model for serving clients.

The Community Lawyering Initiative evolved from Maryland Legal Aid's successful Lawyer in the Library program, which was introduced in 2015 in response to the civil unrest that followed the death of Freddie Gray. The aftermath of the unrest left many Baltimore City residents looking for answers and opportunities to make a difference. Lawyer in the Library was developed to address those concerns. Through the program, Maryland Legal Aid attorneys, paralegals, volunteer attorneys and law students meet with individuals in library branches throughout the state, multiple times per month, to help attendees with their civil legal issues. The Community Lawyering Initiative expands on Maryland Legal Aid's original vision for the Lawyer in the Library program and offers a fresh approach for lawyers to reach and help underserved clients, as well as a unique way for pro bono attorneys to contribute their time and efforts.

One major component of the *Community Lawyering Initiative* is providing criminal record expungements for clients in order to remove barriers to obtaining basic human needs such as safe and affordable housing, employment, and subsistence income. As Maryland Legal Aid has seen in the last year alone, the need for criminal record expungements throughout Maryland is great, and the demand for expungement assistance continues to increase as expungement laws change and people take legal steps to turn their lives around.

As the *Community Lawyering Initiative* develops further, Lawyer in the Library will continue to play a critical role. Maryland Legal Aid anticipates placing attorneys in other library branches throughout Baltimore City and other parts of the state.



Community Lawyering Partners

Maryland Legal Aid thanks the organizations that partnered to help make the Community Lawyering Initiative successful during its first year. Expungement Clinics in St. Mary's County

Since hosting its first expungement clinic at St. Mary's County Department of Social Services (DSS) in February 2016, Maryland Legal Aid continues to see an increase in the number of people making their way to its Southern Maryland office in Hughesville for criminal record expungements. Maryland Legal Aid assisted more than 50 people with expungement petitions in 2016 from St. Mary's County alone.

St. Mary's DSS refers clients who need criminal record expungements to Maryland Legal Aid. Those who qualify for Maryland Legal Aid services can have their expungement filing fees waived. As a result, St. Mary's DSS is now able to designate funds, which would have ordinarily gone towards filing expungement petitions, towards other programs that benefit residents in St. Mary's County.

"Because Maryland Legal Aid was able to get filing fees for expungements waived, DSS did not have to use its limited funds to pay filing fees and instead could use money to fund other employment needs, such as work clothes. We are very happy that our partnership with Maryland Legal Aid has helped so many families achieve their goals."

United States Department of Justice's "National Reentry Week"

Maryland Legal Aid participated in the United States
Department of Justice's (DOJ) "National Reentry Week"
(April 24-30, 2016), which focused on achievements of those returning to their communities after incarceration and the

challenges they face in adjusting to life outside of prison. Maryland Legal Aid participated by welcoming representatives from the DOJ and the White House Legal Aid Interagency Roundtable to the Lawyer in the Library clinic at the Enoch Pratt Free Library Pennsylvania Avenue branch to highlight how civil legal services enhance reentry services. The guests had an opportunity to observe how the project helps to remove barriers for people to obtain employment, housing, and child custody by resolving their civil legal issues and by expunging criminal records.



ExpungeItMD.org

Maryland Legal Aid's extensive work in helping clients expunge their criminal records and hosting clinics with community partners led to the development of ExpungeltMD.org—a free, user-friendly app that enables legal professionals to easily search Maryland criminal records and generate documents to file expungement petitions with the Maryland Courts on behalf of low-income citizens.

Although Maryland Legal Aid leveraged internal resources and talents to design, develop, and test the app, feedback from legal services partners was an important part of the final development phase. Before the official launch of the app, Maryland Legal Aid hosted an open house in September 2016 where legal services partners were invited to test the app and ask questions about its functionality. Since September, more than 120 users (from Maryland Legal Aid and from outside organizations) have signed up to use ExpungeltMD.org.

The database has processed more than 7,000 expungeable cases, which accounts for over \$200,000 in waived fees for eligible clients. ExpungeltMD.org also includes a dashboard tool to easily view anonymous case data and demographics; a calendar of events that displays upcoming legal clinics; and a client receipt page that summarizes a list of cases for which expungement petitions have been filed. Clients have expressed that having the receipt page is very beneficial, since many are able to show it to prospective employers as confirmation that they are in the process of having their record cleared.

On March 7, 2016, Baltimore County signed an agreement with the United States Department of Housing and Urban Development (HUD) to begin unraveling years of housing discrimination against African-Americans and families and individuals with disabilities. As part of the agreement, Baltimore County will take the necessary steps to develop 1,000 affordable housing units that are accessible for individuals with disabilities. Baltimore County also agreed to provide \$30 million in local funds over the next 10 years to help finance the new affordable housing and an additional \$3 million to fund disability upgrades to existing housing units. The HUD agreement was five years in the making and was made possible through the cooperative efforts of Maryland Homeless Persons Representation Project, the NAACP of Baltimore County, and the Maryland chapter of the American

When Sagamore Development announced its plan to redevelop the Port Covington area, many surrounding Baltimore City residents and neighborhoods wanted to ensure that the plan included reinvesting in the community to create new employment opportunities, new schools, and affordable housing. With guidance from Maryland Legal Aid's Director of Advocacy for Housing and Community Development, the Brooklyn, Cherry Hill, Curtis Bay, Lakeland, Mt. Winans, and Westport neighborhood associations joined together to form the South Baltimore Six (SB6) Coalition. Maryland Legal Aid assisted the Coalition with strategies to develop a Community Benefits Agreement and Memorandum of Understanding between the Coalition and Sagamore Development. This agreement, which became effective on July 14, 2016, provides a detailed plan to ensure that the surrounding communities will share in the economic, educational, cultural, environmental, and social benefits associated with the revitalized Port Covington area.

FOUNDATION FOCUS:

Leonard Helen R. Stulman

A generous, three-year grant from The Leonard & Helen R. Stulman Charitable Foundation has helped to create a unique collaborative effort that helps older adults stay in their homes and age in their communities.

Project Household is a partnership between Maryland Legal Aid, Maryland Volunteer Lawyers Service, Pro Bono Resource Center of Maryland, Inc., and Senior Legal Services of the Bar Association of Baltimore City. This project helps coordinate, improve, and expand the delivery of free legal services to low-income Baltimore City homeowners, age 60 and older, in order to help them maintain homeownership and live independently in their communities. To achieve this, Maryland Legal Aid and other Project Household partners employ a holistic approach which focuses on preserving homeownership through four primary areas: avoiding foreclosure or tax sale; promoting the financial stability necessary for homeownership; preventing and addressing financial exploitation; and creating advance planning documents to ensure homes are not lost due to a lack of clear title.

The Leonard and Helen R. Stulman Charitable Foundation grant supports a senior legal helpline, full legal representation in clients' cases, and community outreach and clinics facilitated by attorneys. One of the unique components of *Project Household* is the collaboration with social workers from the Housing Upgrades to Benefit Seniors program (HUBS), who assist *Project Household* clients with identifying home improvements, rehab, and weatherization services for their homes.

Since 2004, Maryland Legal Aid has received grants from The Leonard and Helen R. Stulman Charitable Foundation totaling \$900,000.

Victim-Centered Legal Services

In October 2014, Maryland Legal Aid formed a empowered to access services. partnership with TurnAround, Inc., a non-profit Director Reid stated. that provides counseling and support services to victims of sexual assault, sex trafficking, and domestic violence in Baltimore City and Baltimore County. Victims are often burdened with multi-faceted legal issues associated with sexual assault and domestic violence. Gail Reid, TurnAround's Director of Victim Advocacy, stated, "Maryland Legal Aid is the missing piece in making the justice system more readily available to our clients."

The partnership between Maryland Legal Aid and TurnAround is funded by a three-year Legal Assistance for Victims grant from the United States Department of Justice Office on Violence Against Women. Legal Advocate Josey Elliott from TurnAround provides the initial crisis response and safety assessment to each client seeking legal assistance, while Maryland Legal Aid Staff Attorney Ashley Penater works in TurnAround's office three days a week and provides comprehensive legal services and representation for clients. Through this collaboration, 268 clients (50 more clients than originally projected) have received efficient, streamlined, and victimcentered legal advocacy and support. As a result, victims have voiced feeling less intimidated by the legal process and more

There are a number of comprehensive domestic violence and sexual assault service providers in Maryland that offer assistance to survivors of sexual assault and domestic violence through counseling, shelter and other essential supportive services. However, assistance to address the more long-term, complex legal needs of clients, such as divorce, custody, housing, employment, and consumer issues is often lacking or limited because of stretched resources. High-quality, effective legal assistance provided by Maryland Legal Aid offers survivors sustainable outcomes that enable them to live safe and independent lives.



Ms. W.'s Story

Ms. W. came to TurnAround for help in 2015, after enduring a physically and emotionally abusive marriage with her husband of 13 years. "It was scary at first, not knowing if he would pop up somewhere," Ms. W. recounted. With Attorney Penater's help, Ms. W. divorced her husband in August 2016 and was granted primary physical and sole legal custody of their son, as well as use and possession of their family home. Despite the abusive situation, Ms. W. remained hopeful that her exhusband could maintain a relationship with their son as her ex-husband was granted supervised visitation.

Soon after the Judge's decision, Ms. W.'s ex-husband showed up at her home to look for an item and became enraged when he could not find it. He took his aggression out on Ms. W., but she had the courage to call the police and report the assault. Because of the Legal Assistance for Victims grant, Attorney Penater was able to represent Ms. W. as her victim's rights attorney and guide her through the criminal justice process, explaining each step along the way and helping her prepare her victim impact statement for the court. For the first time, Ms. W. faced her husband in court and held him accountable for his abuse. "It was a very powerful moment," said Attorney Penater. "Ms. W. was able to tap into the raw emotion of everything he had put her through over those 13 long years."

In November 2016, Ms. W. was granted a final protective order against her ex-husband, who is currently incarcerated for charges related to the domestic violence that Ms. W. recounted during her testimony. She shared, "I'm glad I did it. I finally stood up...it's much better than being in a relationship of fear." Ms. W. and her son have since relocated to a new home and are enjoying their new life in peace.

Through funding made possible by the United States Department of Labor, the Baltimore City Mayor's Office of Employment Development and Maryland's Department of Labor, Licensing and Regulation partnered to create the One Baltimore For Jobs (1B4J) program. Community organizations selected to be a part of the 1B4J network explore innovative strategies for re-engaging youth and young adults through job training, education, support services, and career building.

The Maryland Legal Services Corporation (MLSC), Maryland Legal Aid's largest funder, created a special grant to support this project and selected Maryland Legal Aid as one of the organizations to provide legal services to 1B4J program participants. Since May 2016, Maryland Legal Aid has facilitated Know Your Rights presentations for participants at

BUILD, The Ingoma Foundation, City Life Community Builders, Civic Works, Maryland New Directions, and Bon Secours Community Works—six of the supported training sites in the IB4J program. Know Your Rights presentations are incorporated into the 3-4 month job training programs at each site and educate participants about civil legal aid and barriers to employment for Baltimore City residents, such as having a criminal record and unpaid child support. In addition to the presentations, Maryland Legal Aid provides on-site, one-on-one legal advice and criminal record expungements, and if appropriate, legal representation for financially eligible participants.

Mr. Harris' Story

Mr. Harris was in a mentoring program for ex-offenders when he first heard about the services at Civic Works. He enrolled as a trainee in the Baltimore Center for Green Careers program at Civic Works where trainees are required to have a valid driver's license and reliable transportation so that they can be equipped for job placements in the weatherization field. However, at that time, Mr. Harris had neither a driver's license nor reliable transportation.

When Mr. Harris met with Maryland Legal Aid Staff Attorney Ashley Phillips at Civic Works in May 2016, he had already been with the work training program for a few weeks and was interested in resolving a few legal issues that had created roadblocks to better job opportunities. Attorney Phillips provided Mr. Harris with brief legal advice that enabled him to resolve his legal issues with the Motor Vehicle Administration on his own, which further permitted him to restore his driver's license and buy a car.

Two weeks before successfully completing the Civic Works program, Mr. Harris secured an interview with a potential employer. That same day, in June 2016, he was offered a job where he could apply the skills he learned from the program. "I'm now helping build my community back up," he stated. Attorney Phillips also filed several expungement petitions on Mr. Harris' behalf, all of which were accepted. Now with a clean slate and a job that he truly enjoys, Mr. Harris dedicates his spare time to paying it forward through mentoring, investing in people in his community, and promoting the life-changing services he received through the 1B4J program.

After realizing that mental illness was often a barrier to achieving successful outcomes for many clients, Maryland Legal Aid reached out to the University of Maryland School of Social Work for help. In 2009, the University agreed to support the salary of a social work supervisor for one year at Maryland Legal Aid's Baltimore City office. Years later, Maryland Legal Aid now has a Social Work Unit, supervised by a social worker, who was previously an adjunct professor at the University of Maryland before joining Maryland Legal Aid in 2009. She, along with University of Maryland Social Work student interns, work collaboratively with Maryland Legal Aid attorneys to assess client needs and connect them with resources that help alleviate clients' difficult circumstances.

A few examples of how Maryland Legal Aid's Social Work Unit assists clients:

- Helps clients to understand and complete applications for social services;
- Researches various housing, government benefits, or transportation options for clients;
- Links clients to appropriate mental health services and other medical treatment; and

New Partnership in Southern Maryland

As part of the community education provision of the Title III-B contract with Charles County, Maryland Legal Aid's Southern Maryland office formed a partnership with the Charles County Department of Community Services, Aging and Disability Resource Center. This partnership has enabled Maryland Legal Aid to educate homebound Marylanders about their legal rights by including helpful information in their *Meals on Wheels* delivery. In September 2016, *Meals on Wheels* subscribers received their first communication from Maryland Legal Aid—a letter providing an introduction to legal services and a preview of what they could expect to see in future months. Legal topics will focus on the needs of seniors and the issues that they may encounter, such as long-term care, advance directives, consumer scams, and government benefits.



Venable Associate Megan Davis

Building Partners through Venable's Loaned Associate Program

In September, Maryland Legal Aid welcomed Venable Associate Megan Davis to its Baltimore City Housing and Consumer Unit. Megan is one of three attorneys who will work with Maryland Legal Aid and its clients through Venable's Loaned

Associate Program. Over 18 months, each for a six-month period, Venable associates gain additional experience in the courtroom, managing their own cases and interacting with clients. While working at Maryland Legal Aid, Megan was also able to assist clients at community legal clinics, like Lawyer in the Library at the Enoch Pratt Free Library Pennsylvania Avenue Branch, and participate in training opportunities offered to Maryland Legal Aid's staff. Megan shared, "Over my six months at Maryland Legal Aid, I grew both personally and professionally thanks to everyone who readily shared their knowledge, skills, and experiences. Working there further highlighted for me the need for free civil legal services in the community, and I look forward to employing the skills I gained to serve the Maryland community as I continue my legal career."









Coats and Clinics: Free Coats and Legal Advice

Through its annual "Buy 1 & We'll Give 1" campaign, in 2016, Macy's donated 50,000 coats to an international charitable organization, Clothes4Souls, which distributed the coats across the country. Clothes4Souls reached out to Maryland Legal Aid to coordinate the distribution of 2,000 of these coats. This was the second year that Clothes4Souls has worked with Maryland Legal Aid and other community partners in Maryland to help those in need.

Maryland Courts Self-Help Centers Expand to the Eastern Shore

In September 2016, Maryland Legal Aid and the Maryland Administrative Office of the Courts (AOC) celebrated the opening of the newest District Court Self-Help Resource Center location in Salisbury. Maryland Legal Aid staff officially began serving clients at the Salisbury location in July 2016.

Through a contracted partnership with the AOC, Maryland Legal Aid now operates four District Court Self-Help Resource Centers—including walk-in facilities in Glen Burnie, Salisbury and Upper Marlboro—and a call-in center in Annapolis. Self-represented litigants can receive in-person consultations as well as advice via telephone, email, and live chat for a wide range of civil legal matters, including landlord-tenant, consumer matters, debt collection, credit card cases, and criminal record expungements.

Maryland Legal Aid's steady partnership with the AOC continues to empower Marylanders who seek civil legal information and advice for their specific situations in order to confidently represent themselves in court. In 2016, Maryland Legal Aid staff assisted more than 55,000 self-represented litigants through the Self-Help Resource Centers.

Visiting Fellow Program

Maryland Legal Aid partnered with the Legal Aid Foundation (LAF) of Taiwan to host a visiting fellow this past summer. Han-Wei "Steven" Chou is a civil and criminal attorney for the Foundation and spent four weeks last summer observing and learning at Maryland Legal Aid's Baltimore City office and at other legal institutions in Baltimore and throughout the state. The relationship between Maryland Legal Aid and LAF was solidified in 2005 when Maryland Legal Aid's Executive Director, Wilhelm H. Joseph, Jr., participated in an International Forum on Legal Aid in Taiwan and delivered a presentation on the history of Maryland Legal Aid and how the legal aid system functions in the U.S. Since then, LAF representatives have visited other legal aid offices and related entities in the U.S. with the hopes of reforming Taiwan's legal aid system to increase services for low-income people. Steven was the first visiting fellow for the program.




